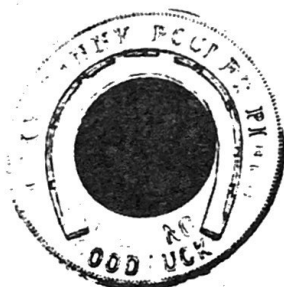

Also known Chevy pieces by state again is listed. This is a contribution from Jim Hemphill (ACE #3) and Joel Reznick (ACE #29). ACE members can read something about Joel in member profile. He was kind enough to answer some of my questions at the recent November Collectible show. Joel is the one that actually identified and discovered that a program of encased Chevy pieces existed in 1948, a fact that even Auto advertising people didn't know about. It seems that there was no records saved thus nothing was passed along to inform current personnel.

Featured on the cover of this issue is one of the known St. Louis Fair encasements. All the encasements from the fair are shared in this issue. These were taken from Kurt Krueger's book, Meet Me in ST. Louis. Are there any others not listed? Perhaps an ACE member would like to enlighten us.

Our membership drive at the November Collectible Show resulted in a few new members. Currently our membership stands at 102 with four new members joining since issue six came out. Also, everyone whose membership expired with issue 6 opted for another year.

And finally, the club auction in issue 6 was a success. There were 98 lots offered from 4 consignors which attracted 15 bidders who submitted 150 bids. Four lots did not receive a bid. Two lots were reduced according to auction rules and one lot had a tie bid which went to the earliest post marked bid. The bidder success rate was 63%. Gross sales were \$251.38. Lots 4, 28, 29, 38, 41, 54, 60, 70, 91, 95 and 97 all received 4 or more bids. Check out the auction in this issue, remember there is no buyer's fee. You must pay postage and insurance on winning lots. And, there is no consignor's fees and minimum bids are permitted. Hope you enjoy issue 7 and feel free to contribute an article or a paragraph in an upcoming issue.

New Maverick Listing

Members are encouraged to send encased mavericks to the editor but not more than 50 at a time. Please do not send encased that have a slim chance of being attributed. General business chains, banks, with generic headings, etc. However, business chains can be sent where there is a chance of a home office, in a case like this the State and city of the home office could be considered the place for attribution.

When sending your list of mavericks send a description and include all information on both sides, as well as the composition of the encased, size, shape, coin denomination and date of coin. If you don't care to send the list you may send the encasements. Package securely and include a check or stamps to cover return postage and insurance indicating the value you desire.

Keep in mind that members may want to contact the owner of a particular piece. So if you want your name and address to appear or to be shared if any inquiry should occur indicate that as well. Several ACE

members have inquired about wanting to buy, sometimes owner is unknown or I didn't keep a record of ownership or the piece is not for sale so a no reply indicates one of the above.

Mavericks are numbered and grouped with the first two letters of the surname or major topic. Each letter group will have its own set of numbers and each piece will also be numbered according to the order received. Also, the issue number has been added for easier future reference.

A maverick has no indication of town and/or state on the encasement and in some cases even lacks the name of the issuing business or subject.

#BO-3 (163) Jack Bolton Marine is from Edgewater, Colo. in Jeffereson County. It's a suburb of Denver with Sheridan Blvd. as the county line, so its just across the street from Denver.

#LI-6 (184) The Lindquist Cracker Co. is from Denver, CO. I also have the one listed and a different style. A round one that says made in Colorado with a 1909 Lincoln cent. The plant was located at 3528 Walnut St., Denver, CO."

It was years before I learned that F.E.F. is the diesinker's mark, namely, F. Earl Fankhauser."

"There is one problem that I hope you will address --the identification of maverick encased coins. I hope that you will insist on some type of proof--D&B, phone book listings, verified street address, etc.--because once a piece acquires an incorrect attribution it is next to impossible to correct it. There are token mavericks from Roseville, Minnesota incorrectly listed as being from "Roselawn" Minnesota in the first maverick listings in the TAMS Journal back in the 1960's that are still being attributed to "Roselawn" to this day. The main reason I bring this up is because of the error on the cover of the February 1996 issue.

You list the Northwestern States Portland Cement Co. encased \$20 gold piece as being from Portland, (OR) and comment that the piece is "most likely the only one of its kind". The plant for this company was (is?) actually located on the northern edge of Mason City, Iowa, 25 miles south of Freeborn County, Minnesota where I was born and raised. The term portland cement refers to a type of hydraulic cement that resembled a limestone found near Portland, England. This area of the country is part of the original Northwest Territory, the first national territory of the U.S. gained in 1783 and given irrevocably to the U.S. in the Treaty of Ghent in 1814. The reference "Northwest" for this area from Ohio to Minnesota was in use long before the Pacific Northwest was reached by Lewis & Clark in 1805.

M.A. "Pete" Peterson (now deceased) was a long time coin dealer in Mason City who was also a good friend of mine. He related the following to me one day in his shop back in the 1970's and I have no reason to doubt his story then or now. The encased gold pieces (both \$10 and \$20 denominations were used) were given to officers and/or members of the Board of Directors after 10 or 20 years of service and were engraved with the recipients name. Over the years a significant number of these pieces found their way to Pete's coin store. Pete would buy the encasements, have the recipients name buffed off the gold encasement ring and sell the "blank" complete with the encased gold coin back to the company! The company would store the pieces until one was engraved to the next recipient. This was much less expensive for the company than having new ones made, even back in pre-gold boom times--in fact, the company would probably have discontinued the practice much earlier if not for this "merry-go-round" system of recovery. Pete recognized some of the same coins coming around four or five separate times.

The day that I was in his shop Pete had three \$20 gold and two \$10 gold encased on hand waiting to be sold back to the company. I purchased several pieces during the early 1980's from Pete as some of these pieces did survive the gold boom of 1979-80. I have handled three \$20 and two \$10 pieces over the past 10-12 years and passed on several others because of price. I have no idea how many were originally made or how many survived but there are still a few out there. Several other dealers have had examples that traded privately over the past few years. I do not know if the company had any other plants and if they used similar encasements--someone may want to do some research now that they know the correct place to start.

A random thought--the best way to catalog all the encased coinage is on a state by state basis (or small reg-

ion) by separate people, but done in a standard format so the info can later be combined, divided, categorized, etc.

I just bought a 1200+ pc encased lot including 120+ Indian cents--it cost a ton but contains a whole lot of neat items.

Let me know if I can help you in any way."

Continued from issue 6, shapes and abbreviations:

RD = Round

BL = Bell

CPL = Chamberpot (Handle left)

CPR = Chamberpot (Handle right)

HS = Horseshoe

MS = Miscellaneous

Rd = Round

WB = Wishbone

Many times the following slogan/s are just given by using the first letters, this will give the reader a point of reference.

Keep me and have good luck/I bring good luck, known in at least one horseshoe (HS) example

Keep me and have good luck/Lucky penny, known in at least one RD example

Keep Me and never go broke, known in at least one HS example and many Rd examples, most Fankhauser ones

Keep me and never go broke/good luck, known in at least one HS and a good number of rounds

Keep me and never go broke/I bring good luck, known in at least 6 BL's, many HS's and several RD's

Keep me and never go broke/S.A., known in at least one RD

Keep me and prosper/Good Luck, known in at least one WB

Keep me and you will have good luck, known in at least 5 HS and many RDs

Keep me and you will never go broke, known in at least one Rd

Keep me clean and I'll not tell what I've seen, known in at least one HS

Keep me for good luck, known in miscellaneous(MS) and RDs

Keep me I am the nimble penny, known in at least one HS and two RDs, (by the way in issue six where nimble was used it was typed as numble, kindly correct this, anyway I think it should be nimble)

Keep me with you for good luck, known in at least one Rd example

Lucky Penny, known in at least one miscellaneous and several RDs

Lucky penny club, known in at least one RD

Lucky penny pocket piece, known in at least two RDs

Lucky penny pocket piece/I bring good luck, known in several RDs

Lucky penny pocket piece/Keep me and never go broke/I bring good luck, known in at least one Rd

Lucky penny pocket piece/save me and have good luck, known in at least one Rd

Detecting Replaced Coins in Encasements

Generally in detecting a replaced coin in an encasement there are one or more of the following :

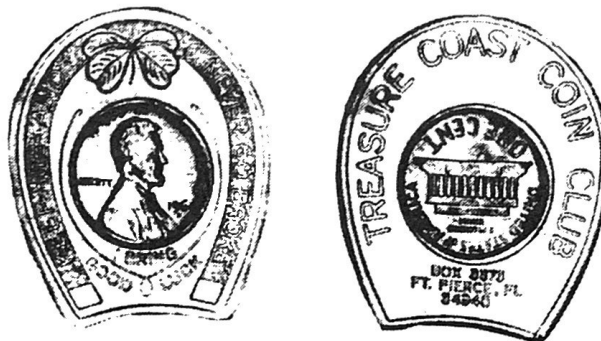
- ♣ There sometimes is a space between the coin and the encasement in one or more spots. Hold the questionable encasement up to the light and examine closely.
- ♣ There may be marks on the encasement where the coin was removed. Examine with a glass much like when you want to grade a coin.
- ♣ The coin may be loose.
- ♣ There may be unequal wear between the coin and the collar. The coin may be a lower grade or a higher grade. The latter is a definite indication that the coin is replaced. Generally you will see a junky coin rather than a higher grade one unless the higher grade has a glaring flaw. However, don't conclude that any lower grade coin is a replacement because sometimes lower grade coins are used in the initial production. This was the case when the Racine Numismatic Society had 1000 encased made. The club supplied the coins and 900 wheat cents were used that graded VF-AU and 100 Indian cents were used that graded filler to good.
- ♣ Glue or solder residue is evident on the coin or the center edges of the encasement.
- ♣ Encasement may be bent, sometimes the collar is concaved but here again sometimes the manufacturer did this at the time of production.
- ♣ Metal flow is into and over the coin, also can occur at production time, this was the case with some of RNS encasements. So, if this is the only flaw it may not be a replacement, always look for one or more of the above.

Prices for encased coins are going up especially scarcer ones so now the deception aspect is creeping into our hobby. Be careful, especially when paying big bucks.

Florida Club produces Encased

The Treasure Coast Coin Club of Fort pierce, Fla. produced a horseshoe encased cent dated 1964, the year of the club's founding. Beneath the coin's obverse is written "I bring good luck." Around the perimeter it states, "Keep me and never go broke." Around the perimeter of the obverse side the encased reads "Treasure Coast Coin Club."

The Penny Man

ENCASED COINS

Peddling encased coins as advertising pieces was a labor of love for Earl Fankhauser, who combined his skill as a salesman with his love of numismatics.

ENCASED CENTS OR, as many people call them, "lucky pennies," are remembrances of days gone by. You may recall getting them from various businesses in your home town when you were a kid. If you hunt, you still can find them at antique shows and flea markets. Many of these pieces carry the name of Earl Fankhauser, known as "The Penny Man," who also happened to be my wife's grandfather. There are many stories about Earl and his "lucky pennies," but little is known about him outside Fort Wayne, Indiana, where he lived his entire life.

Born on April 5, 1902, Frederick Earl Fankhauser grew up poor and lived much of his life that way. Like his father, he never finished high school. After apprenticing in a machine shop, he worked as a mechanic for several auto dealers and later started up a garage with a friend. From 1922 to 1924, he was employed by Pennell Auto as a car salesman.

About this time, Earl became interested in coins, primarily cents. As treasurer for Centennial Methodist Church, he counted the coins in the collection plates on Sundays. Whenever he saw an Indian Head cent in the plate, he swapped it for a new one.

During the Great Depression, the Fankhauser family lost most of its money through various failed business attempts. Typical of what was happening in the rest of the nation, many businesses in Fort Wayne closed. Insurance companies canceled fire insurance on any building vacant more than six months, and landlords were glad to have any tenant just so they could hold on to their properties.

In this environment, Earl found someone who let him have a storefront on Harrison Street for a percentage of his earnings. For a year or so, Earl sold furniture and antiques there and, with a sign in the window, also advertised OLD COINS BOUGHT AND SOLD. At the time, there

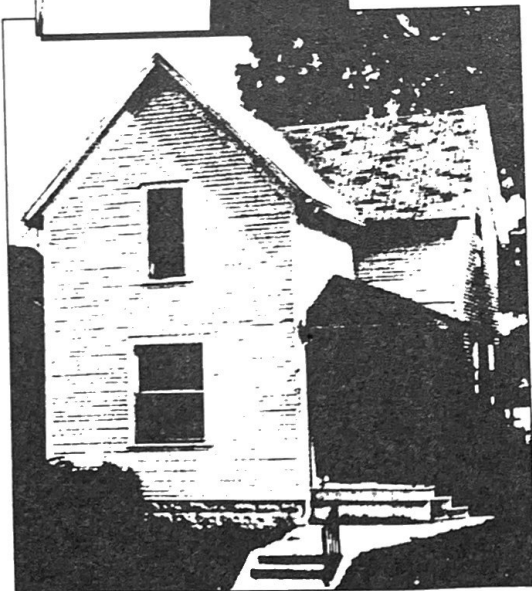

were no coin dealers in Fort Wayne. People were more than willing to sell their old coins and bills for anything above face value, and Earl picked up many bargains. Unfortunately, with the hard times, he could not afford to keep them.

In 1942 Earl got a job as a general laborer for the Wayne Pump Company, and for the first time his family had a steady source of income. The pay was good at \$50 per week, but he hated the factory, preferring to sell and make deals. As a result, Earl led a sort of double life: working in the factory during the day, wheeling and dealing at night.

Once Earl took up selling something, he never really stopped; he just added it to his repertoire. Eventually he was involved in selling just about anything and everything, all the while keeping his regular job at Wayne Pump. He copied photographs, and sold insurance, needles, cars, real estate, antiques, coins, stamps and *encased coins*.

Encased-Coin Days

ENCASED COINS WERE "invented" near the turn of the century, after the Hall-Héroult process revolutionized the production of aluminum. Since it was economical, strong and could be formed easily in a coining press, aluminum was the perfect metal for this inexpensive advertising medium. Encased coins were popular with small businesses. Some were used as calling cards; others were made up as souvenirs or commemoratives.

The popularity of encased coins grew throughout the first part of the 20th century, but once World War II began, the private coining industry stopped production to conserve metals for the war effort. Manufacturing operations resumed after the war ended.

Encased coins were marketed primarily through traveling salesmen who sold various advertising novelties from catalogs and ordered the custom-made pieces directly from the manufacturer. The sales pitch went something like this: "People don't throw away money, so they will keep your advertising piece. People will carry your piece in their pockets as a good luck charm because of the horseshoe and good luck wording on the back, and it will be a constant reminder of you. Encased coins are made of metal, so they will last a long time."

EARL WAS A top salesman. Over an 18-year period, he took orders for more than 670 different encased coins. His work spanned 29 states . . . 134 towns and cities.

We may never know exactly how Earl first got started selling encased coins, but however it happened, he began this venture in 1948. That year he had two pieces made for himself and began taking orders from various businesses around Fort Wayne. Although he started out slowly, before long he was selling far more encased coins than anyone else in the country.

Selling encased coins was a labor of love for Earl. It matched his personality and lifestyle perfectly. It allowed him to work with coins and keep a hand in doing what he enjoyed most, selling things and making deals with people. Always looking to draw attention to himself, it gave him a sort of notoriety about town. He was "The Penny Man."

Earl was a top salesman. Over an 18-year period, he took orders for more than 670 different encased coins. His work spanned 29 states and the District of Columbia, plus Ontario and Quebec, covering a total of 134 towns and cities. He sold them to car dealers, barber shops, political candidates and shoe stores—to anyone who would listen.

If you placed an order, Earl required payment in advance. He typically charged \$12 for 100 pieces, and extra if you wanted something other than a cent in the middle. More was charged for a horseshoe shape or large, round encasement, or for pieces punched for use as a key chain. Most customers just ordered the standard, 32mm round piece with a cent in the center.

Whenever he ran into old customers, he would ask if they needed any more "lucky coins," as he called them, and hand them a post card with his name and address to use for reordering. He often sold encased coins in exchange for goods or services, bartering for shoes for the family, eyeglasses, haircuts—whatever he could get to make a sale.

Throughout the years, Earl had a number of pieces made for himself with his name on them, which he passed out freely. He often left encased coins as tips at restaurants and gave them to prospective customers. He especially liked giving them to children.

Three of his personal pieces were not encased coins at all, but rather solid aluminum pieces. Two pieces were inscribed with season's greetings, another wished sick friends a speedy recovery. Earl had another way of creating calling cards for himself; occasionally he "personalized" coins directly, counterstamping his initials FEF into cents.

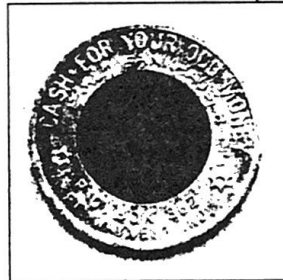
Earl acquired new cents in bulk directly from the bank. After holding

onto them for a few years, he took out ads in *Coin World* and sold them by the roll. He liked selling them because even if he got just 2 cents each, he doubled his money. (Earl had another, more personal reason for liking pennies: they had Abraham Lincoln's likeness on them. Earl had a life-long fascination for Lincoln, who served as his role model. Throughout his life, Earl collected books on Lincoln. He lived just blocks away from the largest private collection of Lincoln memorabilia in the world, housed at the Lincoln National Life Insurance Company. He planned vacations around visiting various Lincoln historical sites across the country. Earl's grandchildren remember being rewarded for reading books on Lincoln and memorizing portions of speeches and various facts about the President's life.)

In 1953 or 1954, Earl came up with the idea of signing each encased coin he sold. He started by putting his initials right in the inscription. They appear on just six pieces. Soon afterward, he started putting his full name and address in tiny letters at the bottom. Earl was unique in this regard; no other encased coin salesman "signed" the pieces he sold. As a result, his name is well known today among collectors throughout the United States and Europe.

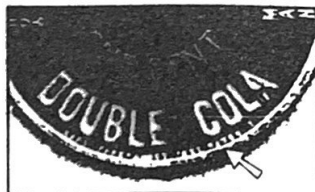
Earl might have gotten the idea from an encased coin he had in his collection. It was made for the Stork Club in New York City by the Osborne Coinage Company of Cincinnati, Ohio. In tiny letters along the lower edge of the brass encasement is OSBORNE COINAGE CIN. O.

A Well-Kept Secret

SINCE EARL WAS a very private individual, many things about him will never be known. Perhaps his most closely guarded secret was where his encased coins were made. Theories abound, but most collectors believe

Earl made them himself on his own press. Others believe he teamed up with a local tool and die maker. It is said—incorrectly—that Earl and his partner also made Fort Wayne's bus tokens. People closest to Earl believe he ordered them from a company in Chicago.

Earl probably started many of these rumors himself. He didn't want any competition, and he didn't want his customers going directly to his source of supply. Even his

own son never was able to get a straight answer from him about where he got them.

In my own investigation, it was the Stork Club piece with the small lettering at the bottom that provided the clue. When I contacted the Osborne Coinage Company, representatives acknowledged the firm had been Earl's supply source. Unfortunately, two years before I made this discovery, Osborne threw away all its dies and records on encased coins. This is especially sad, since Osborne would have had a complete record of every piece Earl ordered, as well as how many of each were produced. A search of the Osborne facility in 1990 uncovered two dies made for Earl that escaped the clean-up, apparently because they were for his solid aluminum pieces, rather than for encased coins.

By Osborne's standards, the encased-coin business involved a lot of customers for little profit. Making the dies required skilled engravers, and it was tough to keep the price low on small quantities. Encased coins were only a minor part of Osborne's business; the firm began making encased coins before World War II and stopped four or five years after Earl stopped selling them in 1965. (Osborne must have felt the loss of Earl's business, since he had been giving the company nearly two orders a week at the time he quit!)

Osborne marketed its encased coins through the Advertising Specialty Group, which published a 3-inch-thick catalog of advertising novelties, including matches, pens, calendars, inexpensive imprinted items and printed material. The firm also put on one or two shows per year.

Because of the vast number of pieces Earl had made with his name on them in the 1950s and 1960s, some collectors mistakenly call all encased coins made by Osborne during that era "Fankhauser pieces." They say Earl's pieces have a certain "look" about them, but are not aware that his source also made encased coins for many other salesmen.

Latter Days

EARL'S RATHER PUBLIC life as a coin collector and dealer in encased coins had its consequences. He was always afraid of being robbed. His children remember that whenever they went on vacations, family members kept their itinerary secret until they returned.

Retirement gave Earl more time to pursue his hobbies, and he kept busy traveling across the country. When traveling by car, he liked stopping at businesses along the way to try to get more orders for lucky pennies. He also enjoyed visiting banks to see what coins they had.

In 1960 Earl developed Parkinson's disease, which slowed him down considerably. He quit selling encased coins in 1965, taking only eight orders that year. He ended the way he began, with a piece made for himself. His last piece carried the "new" postal zip code.

Technological advances in the 1960s impacted the novelty advertising business in a big way, and encased coins were among the casualties. The Bic Pen Company developed an inexpensive ball point pen, an instant advertising marvel. Of even greater significance, printed advertising ma-

How Encased Coins Were Made

.....

THE MANUFACTURING PROCESS for an encased coin started off with the making of a simple die from a piece of soft steel turned in a lathe. The lettering was then hammered into the steel. Once the inscription was complete, the die was hardened and polished.

For decades the Osborne Coinage Company used a set of letter punches to hammer the customer's inscription into the die blank, one letter at a time. In the early 1960s, the firm bought a pantograph engraving machine to mill the lettering into the dies.

After die preparation, blank aluminum rings were punched from a coil of strip aluminum. Customers occasionally sent in their own coins for encasing or made special arrangements with the bank. When special coins were used, a second operation was needed to hand-punch non-standard holes into the ring.

The aluminum rings were then cleaned and delivered to the coining press. The hardened dies were loaded into the press, and the operator prepared the setup. Each encased coin was made by hand. The operator loaded an aluminum ring into the press and then inserted the coin, being careful to align it properly. He then engaged the press, unloaded the completed piece and began again. As the press cycled, the bottom die pushed up to free the completed encased coin. The finished pieces were then sent through another wash operation and sometimes given a protective coating of lacquer.

In the process of punching out the aluminum rings, the aluminum strip at times did not feed properly through the

press. The die then lined up slightly over the last punching, resulting in a "clipped planchet." Since the operator essentially hand-inspected each ring as he loaded it, examples of encased coins with clipped planchets are hard to find.

The coins themselves occasionally had impurities, and some pieces "de-layered" under the pressure of being clenched, forming lines across the coin. This defect is a little easier to find, but still fairly unusual.

Coins that have been broken out of encasements have an unusual look. In the clenching process, the coin's diameter is reduced and its edge becomes concave. Sometimes the coins buckle. These odd-looking pieces sometimes confound coin collectors who find them in circulation.

When Canadian cents are encased, one side usually appears upside-down in relation to the holder. The press operator typically made his setup for Lincoln cents and would not bother to re-orient the dies when switching over to Canadian cents, whose obverse/reverse rotation is not 180 degrees.

Some customers paid extra to have their pieces made into key rings. It is important to know whether the hole in a piece was made at the factory or added later. (Holes added later are considered to be damage, and greatly reduce the value of the piece.) Holes made at the factory usually go through the clover, and the inscription is shifted to either side of the hole accordingly. Holes added later usually are not as "clean" and typically pierce some part of the horseshoe or inscription.

terial of all sorts became much more affordable with the introduction of offset photo lithography. The entire American culture was changing as well. By the end of the decade, encased coins as advertising pieces went the way of malt shops and fins on automobiles.

In 1983, while Earl was on his deathbed in a nursing home, the thing he feared most happened. Someone broke into his home and stole his entire collection of gold pieces and other coins. None of it was ever recovered. The family never told him, and on June 14, 1983, this colorful man passed away quietly of pneumonia.

Searching for Earl's "Lucky Pennies"

OF THE 535 different pieces Earl sold after 1954, all but four carry his name. These four unsigned pieces are attributed to him because 1) they were in his personal collection; 2) they were made using a reverse die typical of his pieces; and 3) in all but one case they were made for repeat customers. Encased coins made after 1954 that do not bear Earl's name most likely are not Fankhauser pieces. However, 104 pieces made before 1955 without Earl's name have been attributed to him because 1) they were found in his personal collection; and 2) they were made using a reverse die typical of his pieces.

Unfortunately, Earl did not keep an example of every piece he had made, nor did he keep any records. There are more undiscovered pieces out there. For the past seven years, I have enjoyed the thrill of the hunt; I suspect you will too. Happy Hunting!

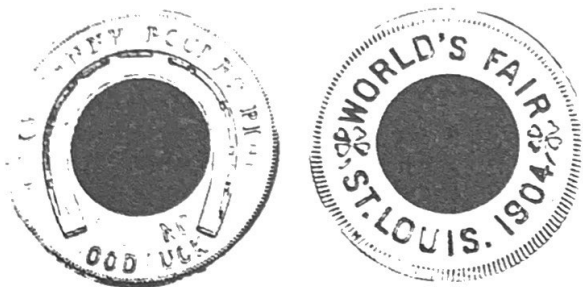

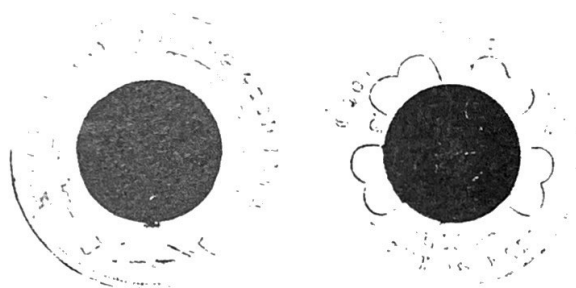
376. Similar, small denticles, different dies, 38mm.

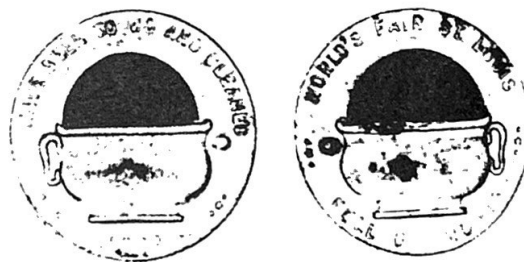
377. Keep Me and Never Go Broke

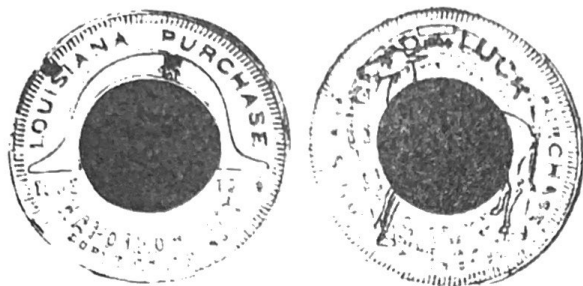

Member Profile

Interview with Joel Reznick (ACE #29) at the November Collectible Show.

Joel was born, raised and still resides in the Chicago area. He currently is a stockbroker and has been for the last 31 years. He is employed by Rodman and Renshaw with their offices being located in the Sears Tower. Joel is married and he and his wife have four children and two grandchildren. The 10 year old grandchild collects baseball cards but his granddad (even with his salesmanship) can't get the youngster interested in exonomia or numismatics which the case I am sure with a good number of ACE members when it comes to children and grandchildren.

The bug for collecting bites us all in various ways. Joel got started in encased collecting after trading two rare Texas transportation tokens for fifty to sixty encased. This then started him off on encased and after a time he discovered the 1948 Chevy pieces. No one to this point documented the fact that the Chevy pieces were produced for dealers around the U.S. The idea was to promote the 1949 Chevy auto which was a radical departure from autos produced from the years before. As ACE members know Jim Hemphill (ACE #4) and Joel are contributing the list of known Chevy pieces in The Casement. In fact this issue has their Kansas and Kentucky lists.

There are approximately 1350 known with six die varieties discovered thus far. A note of interest is that when Joel contacted the Detroit hobby center no one knew anything of the Chevy encased. Joel was surprised because the hobby center has literally thousands upon thousands of materials on all aspects of the auto industry from the past to the present. Needless to say they were happy with Joel's inquiry and subsequent information he provided them.

Chevy pieces is one area that interests Joel, he presently owns about 520 and he is always looking to add to his collection. Joel always likes ornate and early encased. He estimates he has about 4100 different in all. Of this total about 450 are encased Indian cents and about 50 others are of a another denomination besides cents. And yes he has one Teddy Bear and other odd shapes including an eagle and one bread shape to mention a few. There are stories behind some of these acquisitions which will make an interesting article in the future.

Joel is a true collector, besides encased, he collects gaming chips and tokens, transportation tokens, tokens with bridges, cars, ships and elevators pictured, metallic objects produced in the shape of a product, key chains with plastic dials and frogs. Frogs on postcards, medals, and frog statues. In fact Joel admits that if it doesn't move he probably collects it.

Joel belongs to many collectible organizations and he feels that this is the way to go as one begins to specialize. As one specializes he recommends obtaining the books available in the specific fields. According to Joel most of theses hobby books are labors of love with little monetary pay back but all contribute to the hobby and all enhance collector knowledge. Joel stated that once of club is started, (ACE being a fine example) it takes the mystery out of who collects what and members begin to interact with one another.

Joel recommends certain books for identifying mavericks, one that he has found useful is the Street Directory of the Principle Cities of the US in 1908. It consist of 878 pages and list all known streets and numbers for all cities with a population over 500. He has found this so useful that he has teamed up with a fellow collector friend and had a number reproduced complete with a hard cover. Interested ACE members could write to Joel.

In addition to co-sponsoring the Chicago collectible show Joel also is the convention planner for the transportation collectors who meet each year at a different city throughout the U.S.

Joel feels that the popular exonomia collecting fields are encased, gaming tokens and chips, merchant good fors, military tokens and transportation tokens. He feels that most collectors like exonomia from their own states in all of the above areas. Collectors can get a geographic understanding of a location as well as a historical perspective of a developing nation. Tokens with carriages, buggy whips, butter churns, etc. give the collector a good picture.

People who are interested in encased can have a nice collection and can get later date encased and most Fankhauser for \$2 or \$3. As for transportation tokens a collector can spend 30 years accumulating reasonably priced pieces and a similar scenario is true for the merchant collector.

Jerry/ACE Membership:

I believe one of the most important functions of an Association is to establish conventions to be used for such things as catalog numbers, documenting inscriptions, shapes, reverse slogans, reverse die numbers ... You see this with other associations, like for Civil War tokens and transportation tokens. With so little published on encased coins to date, the members of ACE have the unique opportunity to establish those standards going forward. By establishing standard conventions, our hobby will become more organized and unified.

There are many issues that should be discussed, many with no "best" answer. But whatever we decide as a club will become the standard. Who else is there to do this?

I did not get any response on my question to the membership back in August. I thought I would ask again, and maybe the response might be better this time, particularly if others believe in the importance of establishing conventions for our hobby as I do. Also to clarify, there was a typo in how my question appeared in the August issue. The double BACKslash (\) looked the same as the double slash (/). That may have confused some. Here is my proposal again:

I would like to see a standard convention for documenting the inscriptions on encased coins. What I finally came up with for my catalog involved using a single slash (/) to divide lines of type on the same side of the coin and a double slash (//) to divide lines appearing on opposite sides of the coin. This allows the reader to visualize what the piece looks like. A double backslash (\) could be used to indicate the start of the writing on the reverse. What other ideas do people have?

Today ACE is using the only the double slash (//) to separate the front from the reverse. Today you cannot tell where the break in the inscription is above and below the coin. Many times similar pieces are worded the same, and it helps to know the layout of the wording on the piece.

A second fundamental question is how to formulate catalog numbers. I did a survey before settling on a convention. I very much appreciated seeing Jim Lawniczak carry on that convention in the work he did (which was excellent) on the encased coins of the 1901 Pan-American Exposition. The 20 or so collectors and dealers I surveyed selected as best the following convention (wording taken from my book):

IN-WOL-BO-10

ROBERT BOLLINGER / YOUR POPCORN MAN // WOLCOTTVILLE / INDIANA

The first two digits (IN) represent the state. The current postal abbreviations are used. "ON" is used for Ontario, and "QU" for Quebec.

The next three digits (WOL) abbreviate the town. Unlike other cataloging systems that assign a three digit number to each town, three significant alpha characters are used. The alpha characters take up the same amount of space and are easier to translate and memorize. Here "WOL" abbreviates Wolcottville. In the event a piece gives two towns in its inscription, the first town is used (for example see IN-FWA-RE-20).

The next two digits (BO) are the first two letters of the subject of the piece, as it would appear listed in a phone book. In the above example the letters "BO" are used, since you would look up Robert Bollinger by his last name.

Judgment may be required when determining the subject of a piece. Some pieces have two or more possible subjects, such as a person's name and the name of a business. In these cases the name of the larger institution is used. For example, the catalog number for: ED CHAMBERS // YOUR FORD MAN / ALLEN COUNTY MOTORS is IN-FWA-AL-24. Keying off of Allen County Motors, not Ed Chambers.

The last two digits (10) are numbers used to distinguish between pieces. The numbers were assigned beginning with 10, and increment by 10 to allow for future insertions. However, when the same subject had several different pieces made, the numbers increment by just two in order to conserve numbers.

Whenever a piece was made using several different coins during the same production run, an additional alpha digit (-A) is added to the end of the catalog number for each coin used. For example, the two Gold Leaf Tobacco pieces ON-PRI-GO-10-A and -B are identical, except the -A piece has a 1963D U.S. cent inside, and the -B piece has a 1959 Canadian cent. Pieces containing coins from different countries are sequenced starting with the U.S. coins first, and then alphabetically by country (see the CA-LME-RO-10-A through -H series). The extra alpha character is a clear and simple indicator of whether similar pieces were made during the same production run.

Whenever the city or state is not stated on the piece (a "maverick") but has been determined by research, it appears in parenthesis.

This convention, using letters instead of numbers, allows an enormous amount of room for insertions. The catalog numbers are very "readable". It was my hope that one day this system would be used to catalog all encased coins.

The third topic I would like to put before the membership has to do with how mavericks are attributed. I believe there ~~should~~ be physical evidence before a piece is ascribed to a city, for example a listing in a phone book or a city directory. The following pieces were attributed in The Casement (May '96, Nov. '96) as being from Fort Wayne. We could not find them in the phone books or city directories of the day.
